#### In What Areas Will I Work?

My usual work area includes parts of central Kentucky within a general two county area surrounding Shelbyville. I will also work in parts of Southern Indiana. In Kentucky the area includes Anderson, Bullitt, Carroll, Fayette, Franklin, Gallatin, Hardin, Henry, Jefferson, LaRue, Meade, Mercer, Nelson, Oldham, Owen, Shelby, Spencer, Scott, Trimble, Washington, and Woodford Counties. #### What Are My Fees?

Hello. My name is Cary Perkins and I'm the owner of Bluegrass Consulting Forestry located in Shelbyville, Kentucky.

### What is a Consulting Forester?

A consulting forester is a privately employed businessman with a minimum of a B.S. degree in forestry from an accredited college or university who provides professional forestry services to a client for a fee or commission. A consulting forester is your personal representative who is working on your behalf to help solve your forestry-related issues.

I have a B.S. in Forestry and Wildlife **Management from Virginia Tech and** have been in the forestry profession for over 30 years. During that time I not only worked in the woods as a forester, but also served 21 years as **Forest Management Chief of the** Kentucky Division of Forestry in Frankfort. In that position, I was charged with developing and overseeing the Commonwealth of Kentucky's forest management program on a statewide basis, including environmental matters. During that time, I also oversaw timber sales on forestland owned by the Division of Forestry for 15 years. In 2002, I retired to pursue forest management in private practice.

#### **Appraisals For Tax Basis**

When acquiring a piece of wooded property from which timber may someday be harvested, an appraisal is a necessity to establish a basis of the timber value relative to the land itself for future tax considerations. This is often overlooked by landowners when purchasing property. Not having this information may cost considerably in taxes when a timber sale is made.

#### **Trespass Investigations**

Did you know that under Kentucky law (KRS 364.130) if someone crosses your property line and cuts timber on your property without your permission that you are entitled to receive triple damages in court? This law applies if the logger or adjacent landowner did not notify you in advance of their intention to harvest. If called upon, I will estimate the volume and value of any timber illegally cut or removed from your property and then help you recover damages.

In cases of timber trespass, theft, or other legal issues related to forestland, I can provide expert witness testimony in court on your behalf.
